


Middleware Framework

Front-end Framework



Database

With built-in transparent data compression and encryption features, our back-end offers enhanced performance. To secure and encrypt the data, users need not modify programs. Our database provides efficient permission management tools with access controls designed to help users secure sensitive business information.

Security

HTTPS (Secure communication over a computer network)

SSL Certificate

- To provide a high degree of privacy, SSL encrypts data that is transmitted across the web. This means that anyone who tries to intercept this data will only see a garbled mix of characters that is nearly impossible to decrypt.
- SSL initiates an authentication process called a handshake between two communicating devices to ensure that both devices are really who they claim to be.
- SSL also digitally signs data to provide data integrity, verifying that the data is not tampered with before reaching its intended recipient.

JWT Token

The data transmitting using JWT between parties (User Interface to Web API) are digitally signed. So that it can be easily verified and trusted. Also, we are using a secret key which is generated by us with our own algorithm for generating the JWT Token.

Additional Security Features

Password(s) will be encrypted with our secret key which will not be visible to the users or IT admins at customer side. SQL server connection details (username and password) will be stored within the application in an encrypted format to prevent unauthorized DB access.

SaaS / On-Premise Options

Software-as-a-Service (SaaS) is a software distribution model in which a cloud provider hosts applications and makes them available to end users over the internet.

On-premises software is installed and runs on computers on the premises of the person or organization using the software, rather than at a remote facility such as a server farm or cloud.
